4. Chairman's Annual Report:

On behalf of the Community Council I welcome you all to our first 'Live' AGM for a while following restrictions imposed by Covid. We acknowledge the assistance of DGC in making the Library available which allows space for the increased numbers of the public who now attend our meetings. This has been an encouraging trend since restrictions were eased.

As we move back to a more recognisable way of life we have continued to try and serve everyone in our Community. The support and assistance provided by Cllr. Stephen Thompson, our Ward officer Steven Wylie and other officers from DGC is gratefully acknowledged.

Community business:

- The 2021 Remembrance Day Parade returned to its more traditional ceremony which coincided with the centenary of the Royal British Legion. The Church led the service and wreaths were laid by members of the armed forces, merchant navy, relevant organisations, Lochmaben school and the CC. Callum Watson played the lament. The Memorial itself had benefitted from cleansing, a facelift to the plant beds and general tidy up. This was recognised by the award received from DGC and our thanks go to CC member Carol Rogerson and her volunteers.
- The Senior Citizens party was revised again this year partly due to Covid restrictions and the unsuitability of the Community Centre as a venue. Carol Rogerson led a CC team and volunteers delivering over 150 Christmas vouchers to those registered for the event. The vouchers supported Lochmaben's retail shops where they could be exchanged for goods up to a value of £15. We gratefully acknowledge the support provided by local businesses, Hal McGhie, Billy Edwards, DGC and individuals in helping to fund this event which would not otherwise have been possible.
- Our successful application to the Annandale and Eskdale Area Committee Discretionary Budget enabled the replacement of 2 illuminated speed signs located on the main A709 route in October 2021.
- We acknowledge the kind support provided by The George Hunter Trust to help fund separate projects including:
 - o 6 picnic benches in Victory Park installed on our behalf by DGC at no charge.
 - The makeover to The Mercat Cross/ Church Hall Gardens.
- A public consultation event was arranged in the Library to inform of proposals by The Co-op for a store in Lochmaben. This was well attended with regular updates provided during subsequent meetings. The CC maintains a neutral position as the Planning Decision is awaited.
- The annual Art competition for Lochmaben Primary school pupils was reinstated. Winning entries are displayed in the Library and subsequently in Castle Loch cottage.
- Our thanks go to Bob Murray and his volunteers for arranging a Coffee morning to raise funds for future projects.
- General activity continues within the community including painting benches, weeding and garden maintenance. We are grateful to CC members Ian Vidler and Jim Davidson for their hard work.
- Support has been provided to residents campaigning to improve environmental conditions affecting the Mill Loch. This resulted in a meeting with Government agencies and MSP Oliver Mundell which has raised awareness of the issues.
- We have responded to DGC requests including:
 - o Consultations and initiatives in respect of local requirements.
 - o Participation in the Common Good Sub Committee.
- The Community Council requested action from DGC in respect of damaged road surfaces, access to the Lochs, play park equipment and traffic. All information was reported back directly or via Council minutes or Facebook.
- The Facebook page has proved successful in building links with the public and raising awareness of local issues. Our thanks go to Kenelma McCrae for running the site and who will be providing a separate update.

- Following local residents requests, a response was lodged objecting to the Planning application in respect of the housing development at Nethermill Road. This was on the basis of traffic concerns, amenities and the likelihood of future development.
- The careful stewardship of our finances by Treasurer Bob Murray enables us to:
 - o Plan for activity equipment in Victory Park, subject to further local consultation.
 - o Consider taking on some roles previously provided by community groups.
 - Continue to support local sporting and social clubs.

We are grateful to Lochmaben Action Group and Lochmaben Initiative for their separate awards of surplus funds following their dissolution.

Our role as your Community Council is to represent and reflect the views of Lochmaben and District. We sincerely trust we are achieving this but will always welcome constructive comments. We encourage people of all ages to participate at our meetings and if you are keen to do so, join the council. In the meantime we say to everyone in our community 'thank you for your support and we look forward to serving your needs in the future.'

ST commented on the good work of the CC and its modern approach and engagement to community matters.
